HTC Pureenergy Inc. (dba "HTC Pureenergy") Announces Private Placement Closing

Regina, Saskatchewan - HTC Pureenergy ("HTC") announces that it has closed the previously announced private placement, by issuing 6,250,000 units at a price of \$0.08 per unit, for the gross proceeds of \$500,000 ("**Private Placement**"). These units were issued to four subscribers, two of whom are directors of the Corporation. Each unit consists of one common share and one common share purchase warrant ("**Warrant**"). Each Warrant entitles the holder to purchase one common share of HTC at \$0.11 per common share until January 21, 2024. The common shares issued are subject to a hold period under applicable securities law until May 23, 2019. Currently HTC has 38,663,741 common shares issued and outstanding. The Private Placement was approved by the independent committee of the board of directors of the Corporation, the TSX Venture Exchange Inc. and is exempt from shareholders' approval under securities laws.

Proceeds of the Private Placement will be used for business development, including commercialization of HTC's patented Delta Reclaimer product offer and general corporate purposes.

Also, further to the announcement on December 31, 2018, HTC is pleased to announce that it has completed its share redemption/asset purchase/repayment of indebtedness agreement.
