HTC Pureenergy Inc. (dba "HTC Pureenergy") Announces Proposed Private Placement

Regina, Saskatchewan - HTC Pureenergy ("HTC") announces that, conditional upon TSX Venture Exchange Inc. approval, it will issue 2,331,819 units at a price of \$0.11 per unit, for the gross proceeds of \$256,500 ("**Private Placement**"). These units will be issued to directors of the Corporation. Each unit will consist of one common share and one common share purchase warrant ("**Warrant**"). Each Warrant will entitle the holder to purchase one common share of **HTC** at \$0.15 per common share for a period of 5 years after the date of issuance. The Private Placement is a non-brokered Private Placement. Currently HTC has 30,309,195 common shares issued and outstanding.

Proceeds of the Private Placement will be used for business development, including commercialization of HTC's patented Delta Reclaimer product offer and general corporate purposes.
